**Subject:- Regarding Grant of ad-hoc bonus to State Government employees for the financial year 2019-20 who retired / died after 1-4-2020.**

The order for grant of ad-hoc bonus for the financial year 2019-20 to State Government employees has been issued vide even number dated 10-11-2020. In continuation of order dated 10-11-2020 following is clarified :

| (i)   | Whether the employees who have retired from service after 1-4-2020 are eligible for the benefit of ad-hoc bonus for financial year 2019-20.                         | <p>Yes. These employees are entitled for ad-hoc bonus as per terms and conditions referred in order of even number dated 10-11-2020.</p> <p>For these employees 25% of the ad-hoc bonus shall be paid in cash and 75% of the ad-hoc bonus shall be credited to the General Provident Fund Account/ Scheme being put in place on lines of GPF. Director, SI&amp;PF Department will re-open respective GPF account of these retired employees. Director, SI&amp;PF will issue necessary directions in this regard for depositing amount in GPF / New Scheme.</p> |
| (ii)  | Whether the employees who have retired from service after 1-4-2020 and expired thereafter, are eligible for the benefit of ad-hoc bonus for financial year 2019-20. | <p>Yes. These employees are entitled for ad-hoc bonus as per terms and conditions referred in order of even number dated 10-11-2020. As these retired employees are expired, therefore, payment of ad-hoc bonus will be made in cash to the legal heir as per procedure laid down in rules.</p>  |
