ORDER

Sub: Amendment in Rajasthan Civil Services (Medical Attendance) Rules, 2013 in Appendix- I: List of 'Approved Hospitals'

In exercise of the powers conferred under Rule 4 of the of Rajasthan Civil Services (Medical Attendance) Rules, 2013 and as per the decision of the Health Benefit Empowered Committee (HBEC), the State Government hereby includes the following hospitals in Appendix -I, as "Approved Hospital" as defined in Rule 3(5) of aforesaid rules:-


1. Shivam Super Speciality Hospital, Pratap Nagar, Jaipur – (Multi-specialty category)
2. Metro Hospital and Trauma Centre, Golai Mode, Road No. 3, Jhunjhunu – (Multi-specialty category)
3. Arora Hospitale Pvt. Ltd, Krishna Nagar, Bharatpur – (Multi-specialty category)
4. Agarwal Hospital, Sawai Madhopur Road, Tonk – (Multi-specialty category)
5. Marble City Hospital, Kishangarh, Ajmer – (Multi-specialty category)
6. Mishri Devi Eye Hospital Pvt. Ltd, RIICO Phase-I, Nimrana, Alwar -- (Ophthalmology -specialty category)

Note:

- (1) The Order will be effective upto 5 years from the date of issue.
- (2) The hospital shall be bound not to charge, from the State Government employees, more than the rates as may be fixed by the State Government from time to time for approved private hospitals for various treatments, investigations and implants.
- (3) This order will also be applicable for Raj – Mediclaim Policy. A separate agreement will be executed ^{ENG} between State Insurance and GPF Department and hospital concerned in this regard.
