**ORDER**

Sub: Addendum 2 to Implementation of Lock Down Order of even number dated **15.04.2020**.

In accordance with order Nos. 40-3/2020-DM-I(A) dated 21.04.2020 & 24.04.2020 and letter dated 21-04-2020 issued by Ministry of Home Affairs, Government of India, the following amendments are made in the Implementation of Lock Down Order of even number dated **15.04.2020**:

1. In "**Part A. RESTRICTIONS, (2) Prohibited Activities**":  
At S. No. "x." – "shopping complexes" is replaced with "**market complexes**", i.e. '*bazaars*'.

2. In **Part C. PERMITTED ACTIVITIES, the following inclusions are made** (outside the Containment areas of hotspots and clusters):

(1) In Para "**3. SHOPS**"

- m. shops of electric fans
- o. outlets for recharge of prepaid mobile connection
- p. Shops of educational books for students

**NOTE:** to prevent rush at bookshops, system of home delivery of books to parents / students be encouraged :

- District Administration may coordinate with such shops and give permits / passes for them to engage vehicles for home delivery;
- Schools / Colleges / other educational institutions and coaching centres etc. to also coordinate in the process and to communicate the phone numbers of such shops to the parents / students to assist them in placing orders.

In addition to the permitted category of shops listed specifically the following kinds of shops can also be opened:

I. **WITHIN MUNICIPAL LIMITS**

All registered shops that are in the nature (1) "neighbourhood shops" (i.e. in and near residential areas), (2) stand-alone shops (i.e. individual shops), but which are not a part of any market complex (*bazaar / shopping complex building*) as well as (3) shops in residential complexes, with 50%

strength of workers and subject to the precautionary measures specified in the Order dated April 15<sup>th</sup>, 2020, i.e. wearing of face masks, social distancing etc. being mandatory.

It is clarified that this **does not include** shops in market complexes (bazaars) and multi-brand and single brand malls.

## II. **OUTSIDE MUNICIPAL LIMITS**

**All registered shops**, including those in market complex (*bazaar / shopping complex building*), with 50% strength of workers and subject to the precautionary measures specified in the Order dated April 15<sup>th</sup>, 2020, i.e. wearing of face masks, social distancing etc. being mandatory. **This does not include shops in multi-brand and single brand malls.**

It is **further clarified**, in context of I. and II. above, that the term "**shop**" covers such outlets that are selling items / products and **does not include establishments** registered under *The Rajasthan Shops and Commercial Establishments Act, 1958* **which provide "service"** like restaurants, eateries, saloons, parlours etc. In such cases the Order dated April 15<sup>th</sup>, 2020 would be applicable.

3. In para "**9. AGRICULTURE, HORTICULTURE & Allied Activities**" the following addition is made :


"xii. Facilities for export / import such as Pack houses, inspection and treatment facilities for seeds and horticulture produce.

xiii. Research Establishments dealing with agriculture and horticulture activities.

xiv. Inter and intra State movement of planting materials and honey bee colonies, honey and other beehive products.

4. In para "**10. Social Sector**" the following addition is made:

c. "bed side attendants and care givers of senior citizens residing in their homes."
